1 point

- too slow (per point)
- over-bitted (per maneuver)
- out of frame (per maneuver)
- break of gait or walk or trot for 2 strides or less
- wrong lead or out of lead for 2 strides or less

2 points

- break of gait or walk or trot for more than 2 strides
- break of gait or slow, except when corrected at moment of call
- wrong lead or out of lead for more than 2 strides
- three rises (per maneuver)
- out of lead or close containing more than 2 strides when changing leads
- making more than 2 strides when making a stride out change
- making more than 2 strides in top down stride or when making a millback
- severe disturbance of any degree

3 points

- Major disobedience (kick, bite, back, rear, stop) or wild rears

Off Pattern (OP) - to be placed below horses performing all maneuvers

- 2 or 3 rises in walk maneuver
- 1 or 2 rises in trot maneuver
- repeated failed disobedience
- use of two leads (except junior and L1 horses shown in a walk/trot pattern), more than one change between right and left legs or between front legs (except in the last rein)

Disqualified - 0 Score

- legal equipment including hair black, braided or braided manes, or all coloration harnesses
- ill-fitted or misused
- wild rears
- leaving working area before pattern is complete
- broken wheel rim
- fall or horse fall

1 point

- too slow (per gait)
- over-broke (per maneuver)
- out of frame (per maneuver)
- break of gait at walk or trot for 2 strides or less
- wrong lead or out of lead for 2 strides or less

3 points

- break of gait at walk or trot for more than 2 strides
- break of gait at lope, except when correcting an incorrect lead
- wrong lead or out of lead for more than 2 strides
- dropped reins (per maneuver)
- out of lead or cross-cantering more than 2 strides when changing leads
- trailing more than 3 strides when making a simple lead change
- trailing more than 3 strides in loss of lead when making a retrace
- severe disturbance of any obstacle

5 points

- blatant disobedience (kick, bite, back, rear, etc.) for each refusal

Off Pattern (OP) - to be placed below horses performing all maneuvers

- disturbances of saddle movement
- incomplete maneuvers
- repeated failure of obedience
- use of two hands (except junior and LF horses shown in a snaffle bit bridle) more than one
- lagged between split reins or any lagged between hand reins (except in the two rein)

Disqualified - 0 Score

- legal equipment including foot block, padded or laced manes, or tail extensions
- brakes
- disrespect or misconduct
- WFLA abuse
- leading working area before pattern is complete
- improper western attire
- fall of rider/horse
