1 point

- too slow (per marker)
- over-slowed (per marker)
- out of frame (per marker)
- break of gait or walk too fast for 2 strides or less
- wrong lead or out of lead for 2 strides or less

2 points

- break of gait at walk or trot for more than 2 strides
- break of gait at lope, except when making an assumed lead
- wrong lead or out of lead for more than 2 strides
- dropped leads (per marker)
- out of lead or cross cantering more than 2 strides when changing leads
- lurching or cutting 3 strides when making a simple lead change
- lurching more than 3 strides in lead departures or when making a mistake
- severe disqualification of any obstacle

3 points

- failed obstacle or (kick, bite, back, rear, etc.) for each refusal

Off Pattern (OP) - to be placed below fences performing all maneuvers

- 2 or more OP adds maneuver
- all OPs are recorded
- record all OPs in backcrosses
- use of two hands (except jump and 3 horses shown in a single backcross), more than one finger between sets, or any fingers between most sets (except in the two-hand)

Disqualified - 0 Score

- legal equipment including hoof blocks, gaited or soled shoes, or ill conditions
- wire ties
- changed or re-mounted
- a BS failure
- stopping working area before pattern is complete
- improper administration
- fall of horse/ rider

1 point

- too slow (per gait)
- over added (per maneuver)
- out of frame (per maneuver)
- break of gait or walk or trot for 2 strides or less
- wrong lead or out of lead for 2 strides or less

2 points

- break or gait of walk or trot for more than 2 strides
- break of gait at top, except when executing an incorrect lead
- wrong lead or out of lead for more than 2 strides
- dropped reins (per maneuver)
- out of lead or cross-cantering more than 2 strides when changing leads
- bucking more than 2 strides when making a single lead change
- bucking more than 3 strides in lops departures or when making a roll back
- severe disturbance of any gait

3 points

- enter, dismountance (kick, cut, back, rear, etc.) for each refusal

Off Pattern (OP) - to be placed below leaves pertaining to maneuvers

- eliminates or adds maneuver
- incomplete maneuver
- repeated or stated dismountance
- use of two hands (except jumper and CI horses shown in a walk or trot pattern), more than one finger between split reins or any fingers between reins (except in the top roll)

Disqualified - 0 Score

- legs equipment including lead/lead, treated or banded reins, or lead connectors
- incorrect
- dropped or misused
- wills abuse
- leaving working area before pattern is complete
- incorrect wooden shoe
- fall of horse/rider
