**1 point**  
 - too slow (201 gait)  
 - over bridled (201 mane/ear)  
 - out of frame (201 front/side)  
 - break of gait at walk or trot for 2 strides or less  
 - wrong lead or out of lead for 2 strides or less

**2 points**  
 - break of gait at walk or trot for more than 2 strides  
 - break of gait at jog, canter or when changing or reformed lead  
 - wrong lead or out of lead for more than 2 strides  
 - straddled leads (201 mane/ear)  
 - out of lead or one centering more than 2 strides when changing leads  
 - looking more than 3 strides when making a simple lead change  
 - looking more than 3 strides in loose departures or when riding a railback  
 - severe disturbance of any obstacle


**0 points**  
 - didn't do woodwork (kick, side back, rear exit) or used release

**Off Pattern (OP)** - to be placed on all horses performing all maneuvers  
 - all knees or both knees set  
 - excessive mane/ear  
 - repeated blatant disobedience  
 - use of two hands (except at trot and L1) to slow down in a circle or backman, more than one finger between both reins or any fingers between hand reins (except in the two-hand)

**Disqualified - 0 Score**  
 - legal equipment including head block, blinker or blinker bars, or tail extension  
 - lame shoe  
 - dropped or miscolored  
 - wrong gait  
 - stopping working side before saddle is complete  
 - improper action at trot  
 - fall of horse/side

- faults**
- too slow (per gait)
  - over-bitted (per maneuver)
  - out of frame (per maneuver)
  - break of gait at walk or trot for 2 strides or less
  - wrong lead or out of lead for 2 strides or less
- penalties**
- break of gait at walk or trot for more than 2 strides
  - break of gait atlope, except after contacting an inclined lead
  - wrong lead or out of lead for more than 2 strides
  - stopped riding (per maneuver)
  - out of lead or cross-cantering more than 2 strides when changing leads
  - trotting more than 2 strides when making a simple lead change
  - trotting more than 2 strides in lope departures or when making a rollback
  - severe disturbance of any obstacle
- faults**
- Disturb of dressage (back, rib, back, rear, etc.) for each reinset
- Off Pattern (OP)** - to be placed below horses performing all maneuvers
- off-hands or addl. maneuvers
  - incomplete exercises
  - repeated breaks of adherence
  - use of two hands (except) under and Lt. horses shown in a snaffle or (discretionary) more than one finger however split reins or any fingers below the hand rate (except in the helmet)
- Disqualified - 1 Score**
- illegal equipment, including hoof block, grinded or banded manes or tails, release on lameness
  - demerit or misconduct
  - willful abuse
  - leaving working area before pattern is complete
  - improper Western attire
  - fall of horse/ridr
